- Members may not distribute internal GSWA documents unless authorized by the Chair

Voting Process

- to be sanctioned by the new GSWA Board
- 'Membership'
- Two Votes per registered stewardship group
- General voting at AGM's and/or special votes as deemed by the Board

- 'Board Members'
- Acts on behalf of and is subordinate to the membership
- Will vote at meetings*
 for day to day activities
 of the organization

*meeting occurences to be determined by the new GSWA Board

Chair

- Spokesperson and liaison with media, government
 & other organizations
- Signing authority and deemed to be agent of GSWA acting under the authority and express intention and direction of the whole Board



Shall exercise general & active supervision over * employees (if applicable) * preparation & submission of reports * preparation of the annual budget * execution of contracts, documents and shall have such other powers and duties as may be assigned by the Board of Directors

Vice Chair

- Is vested with all powers and shall perform all duties of the Chair
- Shall sign such contracts, documents or instruments in writing
