## 1. Milfoil Report Response (Refer to Addendum)

- Chair Lesley Flowers gave an overview of the draft report (including observations and proposals) created by the sub-committee review
- Comments and Suggestions to draft report: Lin – control sites not part of the plan; GSWA will remain an active partner Alex – improved signage (buoys) on stocked sites

#### 2. Water Level Control – Paul Sajatovic (Conservation Sudbury)

In past GSWA meetings there has been concern regarding high lake levels in area lakes, particularly Richard Lake. Active beaver activity and a rainy fall exacerbated high levels in Richard Lake during October 2013.

Conservation Sudbury monitors 3 watersheds: Wahnapitae, Vermilion/Onaping, and Whitefish.

 Wahnapitae dams: Dams are operated by Ontario Power Generation Wahnapitae serves as an important reservoir – a balance must be struck  Vermilion/Onaping dams include: One run-of-the-river dam Three flood dams A complex Vale dam system An Onaping Lake dam operated by Domtar

Dams can be a contentious topic, however, there have been no major dam failures in Greater Sudbury. Backed-up water that does not affect infrastructure or public safety is considered a low priority by the City of Sudbury. The City of Greater Sudbury *will* respond to beaver dams, ice blockages, and debris blockages if they impact on municipal infrastructure or public safety. Private property, however, is responsibility of private property owners. Furthermore, private property owners are liable for damage extending beyond their property to neighbouring land.

If Spring 2014 proves to have reasonably slow warming and moderate rainfall, flooding should not be a major concern. A rapid transformation of conditions, however, could be problematic considering the amount of snowpack and ice. A flooding contingency meeting will be held between the city and its stakeholders.

#### 4. Rain Garden Workshop – March 31, 2014

Coalition for a Liveable Sudbury (CLS) has received a RBC Blue Water Fund grant to host a rain garden workshop for landscape contractors and designers. The grant, however, will not likely cover all required costs. Thus, CLS would like GSWA's support to fund this event.

The information in the Hutchinson Report states that large amounts of Phosphorus can be removed from a functioning septic system. Should this be incorporated into the booklet? Alternatively, Fairbank and GSWA could jointly present the revised pamphlet to the Lake Advisory Panel; it could then be produced without extra cost.

# March 19, 2014 GSWA response to the <u>Enviroscience 2013 Milfoil Report</u> to the City of Greater Sudbury

On February 17, 2014, the Greater Sudbury Watershed Alliance hosted the presentation of the report by Kyle Borrowman (Enviroscience) with an introduction of the project by Stephen Monet, Manager of Environmental Initiatives for the City of Greater Sudbury. As a result a sub-committee was formed to prepare a response for the general membership of GSWA to consider and then upon editing/approval have presented to municipal council.

Observations:

- It was felt that a three year project was not long enough to see significant results especially given the hot and sunny 2012 summer which spurred intense Eurasian Water Milfoil growth.
- GSWA is disappointed in the results reported and in the quality of data presented in the report. Really only one lake, St. Charles showed a significant reduction in Eurasian water milfoil (EWM). We are disappointed that control sites (necessary for comparison of data) were stricken from the original plan in order to meet the budget.
- There has been some controversy about the selection of weevil stocking sites and generally it was felt that stewardship groups of the individual lakes should be part of the discussion when choosing sites and the ultimate choices and reasoning should be communicated to the stewardship group.
- Better stewardship of lakes with a EWM issue was also discussed. The reduction of boat traffic in EWM areas, the provision of shoreline buffers for increased success of overwintering of weevils, the collection of floating stems and discontinuation of cutting by lake front residents was suggested.

Education of the public about EWM was also discussed since many are not aware that their actions directly impact the growth of EWM.

# Proposal:

- First we recommend continuing a Eurasian water milfoil abatement project but with some important differences. We would like to see all lakes that were part of the 2011 to 2013 pilot project, with the exception of Simon Lake (algae prevents proper seeding of weevils) monitored for the 2014 season. We would like to see a small number of sites seeded with weevils and then data collected through rigorous sampling methods with control areas built into the investigative design. We would like to see the monitoring, seeding, data collection and interpretation supervised by an independent scientist with expertise in biological investigations. GSWA is committed to remain an active partner in this initiative through citizen engagement. A decision can be made upon completion of the 2014 project as to whether we should pursue this EWM abatement method any further.
- Secondly we would like to encourage support for the research by College Boreal led by Andre Ferron into the overwintering of weevils in the laboratory. Success would ensure availability of weevils earlier in the season.
- Thirdly GSWA recommends that the City of Greater Sudbury develop a Eurasian water milfoil Strategy or Policy. This would include strengthening the role of stewardship of all the lakes affected by EWM. It would also include by-laws to support that stewardship. The use of motor boats in milfoil abatement areas should be prohibited with improved signage provided around treatment areas. Boaters should be discouraged from disturbing all milfoil patches. Buffered zones on shoreline properties should be mandatory. There have been many initiatives to encourage a natural shoreline over quite some time, yet lawns and hard surface constructions still line our lake shorelines. Continued education especially regarding collection of floating EWM should also be part of the policy.

The Greater Sudbury Watershed Alliance is still optimistic about the role a biological control might have in abating the growth of EWM. We are proud that a group of lake stewards was able to work collaboratively with the city and that the council saw fit to support the project. It is a testament to the importance our lakes have in our city and our recommendations are based on those values.
