# **GSWA Executive Report**

# Monday August 18, 2014

May – Lilly Noble and I met with David Shelsted regarding GSWA's letter of support for the part 2 order request made by the Minnow Lake Restoration Group. We received a letter that said the city was currently preparing the terms of reference for a watershed study of Ramsey Lake. The terms of reference will include state of the art and best management practices for storm water management and treatment. Also a prioritization and implementation plan of treatment improvements in Ramsey Lake. GSWA will be recognized as a key stakeholder in the watershed study.

The Board of Directors voted to not rescind the part 2 order request.

June - The Water and Waste Water Plan was reviewed at a PIC and the Board of Directors approved a letter from GSWA supporting the components of the plan. The Board of Directors meeting was held on June 19<sup>th</sup>. Letters of congratulations to Junction Creek – Earth Day Home Town heroes and Conservation Sudbury for RBC grant re storm water management at Northern Watersports Centre. Also a letter sent to council and planning recommending mandatory septic inspections. Sent out a press release re Preventing Blue Green Algae... not printed or picked up by any one....

July – available members of the Milfoil committee met with Stephen Monet re the GSWA Milfoil report and agreed on some ways of moving forward with some of our recommendations. Both Stephen Monet and I presented our milfoil reports to council (full report was in their handouts). Thank you for those who were able to attend. A large group in support of a presentation is very effective in sending a strong message.

A second Milfoil committee meeting was held to review the plans for monitoring weevils and milfoil in 2014. This work is beginning August 17<sup>th</sup>.

Apart from the milfoil work, Linda Heron, Lilly Noble and I met with S. Monet and Mark Simeoni regarding GSWA's concern about the use of the Hutchinson Report for planning waterfront development. We were assured that the report was only part of the information gathering for the formation of a very conservative and protective plan for waterfront development. The reality is that the actual type of development that takes place is one lot here, one lot there and imposing standards that no one else has had to abide by becomes difficult... ie not supported by OMB.

August – I attended the LAP (now Watershed Advisory Panel) presentation to Council and Minnow Lake CAN.

I have made two requests of the Board of Directors regarding disbursement of money - \$ 500 to 1000 to NORSE/ Odin Project (I'd like to give them \$ 1000) and \$200 to Water Journey. Lilly, Linda, Shannon and I will be part of the Anishnaabe Kweg, women's water journey around Ramsey Lake. The \$200 will go towards the cost of the feast held after the journey. Sept 19<sup>th</sup> @ 6 am, email Lesley for more details.

Now what is not complete: Brochure, translation of Septic Booklet, there should also be more on the website.
