1. PRESENTATIONS BY GSWA MEMBERS:

A. Introduced by Alex Cieslewicz and presented by Kate Kearney, both from Richard Lake, a Powerpoint presentation on the dangers of building a ferrochrome smelter in Coniston, a brownfield site in the City of Greater Sudbury.

Richard Lake presentation: Concerns over Proposed Ferrochrome Smelter

Kate showed the risks of Chromium 6 (Cr(VI) or hexavalent chromium) entering into our soil, water and air and emphasized that this carcinogen would affect our drinking water both in Ramsey Lake and from the Wahnipitae River. There were several action items attached:

- 1) writing letters to Noront, to the CGS Councillors and Mayor;
- 2) helping to raise funds for and place signs that show the range of the Cr(VI) effects on the city:
- 3) attending an educational forum on Cr(VI) to be held in Coniston on April 28th.
- B. Sheri Johnson and Linda Heron, Strategic Planning Committee, of the Vermilion River Stewardship, made a Powerpoint presentation on the Lower Vermilion Source Water Project Quality Monitoring Project.

VRS Presentation: Lower Vermilion Source Water Quality Monitoring Project, by Sheri Johnson & Linda Heron

Sheri and Linda demonstrated what can be accomplished when a community organization is open to working with universities and other interested researchers to address concerns about water quality. The study involved sampling at 28 sites, 6 months a year over 3 years

in a water quality study spanning from a baseline several kilometers above the old Moose Mountain site near Capreol to the bottom of the watershed at the confluence of the Vermilion with the Spanish River. Their data has been shared with Vale and is being used by the City of Sudbury for their sub-watershed studies.

2. REQUEST FROM THE FLOOR: There was a request made by Mr. Eady from Wahnipitae for the GSWA to write a letter to the city giving our position on the casino to be built. The discussion on this matter focused on the parking lot for the recreational complex to be built on the Kingsway. Mr. Denton, our Board Chair, took a straw poll among those present to determine their level of support for reacting to both issues.

The result showed general support for both issues:

- 1. Salt concentration in Ramsey Lake increasing due to the parking lot of the Kingsway Entertainment Development; and
- 2. Contamination of Ramsey Lake from the proposed ferrochrome smelter if built in Coniston.

The board will take this support into consideration at its next meeting.
